**AUDITOR'S REPORT TO THE BOARD OF DIRECTORS OF  
BIJLEE TEXTILES LTD.  
ON LIMITED REVIEW OF UNAUDITED FINANCIAL RESULTS**

We have reviewed the accompanying statement of unaudited standalone financial results of Bijlee Textiles Ltd. ("the Company") for the quarter ended 30<sup>th</sup> June, 2015 being submitted by the Company pursuant to Clause 41 of the Listing Agreement, except for the disclosures regarding 'public shareholding' and 'Promoter and Promoter group shareholding', which have been traced from the disclosures made by the management and have not been audited by us. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with applicable accounting standards specified under section 133 of the Companies Act, 2013 read with Rule 7 of the Companies (Accounts) Rules, 2014 and other recognised accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.

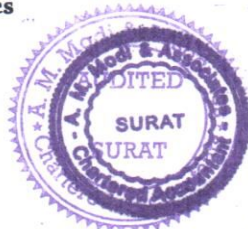
