**AUDITOR'S REPORT TO THE BOARD OF DIRECTORS OF  
BIJLEE TEXTILES LTD.  
ON LIMITED REVIEW OF UNAUDITED FINANCIAL RESULTS**

We have reviewed the accompanying standalone statement of unaudited financial results of **Bijlee Textiles Ltd.** ("the Company") for the quarter ended 30<sup>th</sup> September, 2015 and the standalone statement of assets and liabilities as on the date. Except for the disclosures regarding "Public Shareholding" and "Promoter and Promoter Group Shareholding" which have been traced from disclosures made by the management and have not been audited by us.
